

**TILLAMOOK SUMMER SWEEPSTAKES (“Sweepstakes”)  
OFFICIAL RULES (“Official Rules”)**

**NO PURCHASE OF ANY KIND IS NECESSARY TO ENTER OR WIN A PRIZE.  
A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.**

**YOU HAVE NOT YET WON.**

**BY SUBMITTING AN ENTRY TO THIS SWEEPSTAKES DURING THE SWEEPSTAKES PERIOD, YOU AGREE TO THESE OFFICIAL RULES, WHICH ARE A CONTRACT. SO READ THEM CAREFULLY BEFORE ENTERING. AMONG OTHER THINGS, THIS CONTRACT INCLUDES INDEMNITIES FROM YOU TO THE RELEASED PARTIES AND A LIMITATION OF YOUR RIGHTS AND REMEDIES.**

**ODDS OF WINNING WILL DEPEND ON THE TOTAL NUMBER OF ELIGIBLE ENTRIES RECEIVED. THE SWEEPSTAKES IS ONLY OPEN TO LEGAL RESIDENTS OF FL, GA, AL, SC, NC, TN, VA, AND KY, USA WHO ARE 18 YEARS OF AGE (19 FOR AL RESIDENTS) OR OLDER. VOID WHERE PROHIBITED BY LAW OR RESTRICTED BY LAW.**

**SWEEPSTAKES PERIOD:** The Sweepstakes begins at 12:00 AM US Pacific Time (“PT”) on June 15, 2026 and ends at 11:59 PM PT on July 31, 2026 (the “Sweepstakes Period”). The computer clock of the Administrator is the official time-keeping device in the Sweepstakes. By participating, participants (“Participants”) agree to be bound by these Official Rules and the decisions of Tillamook County Creamery Association (the “Sponsor”), which are binding and final on matters relating to this Sweepstakes.

**ELIGIBILITY:** Sweepstakes is open only to legal residents of Florida, Georgia, Alabama, South Carolina, North Carolina, Tennessee, Virginia, and Kentucky who are at least eighteen (18) years of age or the age of majority in their state of primary residence (whichever is older) at time of Sweepstakes Entry. Employees, officers and representatives of the Sponsor, Southern Made Services, LLC (the “Administrator”), Fandango Loyalty Solutions, LLC (“Fandango”), Publix Super Markets, Inc., and each of their respective parents, affiliates, subsidiaries and web-design, advertising, marketing, fulfillment, judging and promotion agencies, or other agency involved in the administration, development, fulfillment and execution of this Sweepstakes, and their immediate family members and household members, as each is defined below, are not eligible to participate in the Sweepstakes. “Immediate family members” shall mean parents, stepparents, children, stepchildren, siblings, stepsiblings, or spouses, and their respective spouses. “Household members” shall mean people who share the same residence at least three (3) months a year, whether or not related. Winning a Prize (defined below) is contingent on fulfilling all requirements in these Official Rules. All federal, state and local laws and regulations apply. Void here prohibited or restricted. All Sweepstakes Entries are the property of the Sponsor.

**HOW TO PARTICIPATE:** During the Sweepstakes Period, there are two (2) ways to participate. **1) Entry with Purchase:** To receive one (1) Sweepstakes Entry (defined below), follow these directions. First, buy one participating Tillamook product at any physical Publix store in the U.S. during the Sweepstakes Period. Online purchases are not eligible for entry via this entry method. See Appendix at end of these Official Rules for a list of all participating products. Then, visit [www.tillamooksummersweepstakes.com](http://www.tillamooksummersweepstakes.com) (the “Website”) and complete the online registration form, which requires your first name, last name, email address, complete address, and age verification. Then submit an image of your full receipt during the Sweepstakes Period for validation. Submissions are reviewed by Fandango Loyalty Solutions, LLC within 2-5 business days. Once your receipt has been validated, you will receive an email confirming your Sweepstakes Entry. For each validated receipt submission, you will receive one (1) Sweepstakes Entry (each, a “Purchase Entry”). Limit: One entry per person per day during the Sweepstakes Period. **If you enter via this method, each daily entry requires a separate product purchase and receipt. YOU ARE NOT REQUIRED TO PURCHASE A PRODUCT TO ENTER THE SWEEPSTAKES, AND PURCHASING A PRODUCT WILL NOT INCREASE YOUR CHANCES OF WINNING.**

**2) Alternate Means of Entry that Does Not Require Purchase or Payment:** To receive one (1) Sweepstakes Entry without making a purchase (“AMOE Entry”, together with Purchase Entries, “Sweepstakes Entries”), visit [TillamookSweeps.entertowinprizes.com](http://TillamookSweeps.entertowinprizes.com) (the “AMOE Website”), and complete the online form to receive one Sweepstakes Entry. The form will request information such as your first name, last name, email address, complete address, and age verification. For each AMOE Entry you submit, you will receive one (1) Sweepstakes Entry. Limit: One entry per person per day during the Sweepstakes Period. Even if you purchase a participating product and enter one day via entry method 1 above, you can enter other days via this AMOE Entry during the Sweepstakes Period.

Sweepstakes Entries generated by script, macro or other automated means, and Sweepstakes Entries by any means which subvert the entry process, are void. By submitting a Sweepstakes Entry, you agree to the Official Rules and are willing to provide your information to the Sponsor and the Administrator and Fandango Loyalty Solutions, LLC. No photocopied or mechanically reproduced Sweepstakes Entries accepted. Sweepstakes Entries become the property of the Sponsor and will not be returned.

There is a limit of one (1) Sweepstakes Entry per person per day during the Sweepstakes Period, regardless of entry method, using only one (1) email address. Limit one (1) Sweepstakes Entry per receipt submission or AMOE Entry. Sweepstakes Entries received from any person in excess of the stated limitation, or which are incomplete, illegible, corrupted, damaged, destroyed, forged, false, lost or misdirected, will be void. Subsequent attempts made by the same

individual to submit multiple Sweepstakes Entries in a given day by using multiple or false contact information or otherwise may be disqualified. Prizes that have already been distributed may be revoked, cancelled, or voided at any time if it is determined that the associated Sweepstakes Entries violated these Official Rules.

Multiple individuals are not permitted to share the same email address. Sponsor reserves the right to reject any Sweepstakes Entry that it believes, in its sole discretion, is fraudulent, incomplete or otherwise invalid. None of the Released Parties (as defined below) are responsible for Sweepstakes Entries, Sweepstakes-related e-mail, Sweepstakes-related push notifications, claims or notices that are lost, late, illegible, misdirected, damaged, incomplete or incorrect.

Any and all information provided in connection with this Sweepstakes is subject to the Sponsor's Privacy Policy available at <https://www.tillamook.com/privacy-policy>. By entering the Sweepstakes, Participants hereby agree that the Sponsor and Administrator and Fandango Loyalty Solutions, LLC may collect and use their personal information submitted with their Sweepstakes Entry. Among other things, the information Participants provide may be used to send company updates and announcements from the Sponsor concerning the company and its products. At the time of entry, Participants may be given the opportunity to opt-in to receive marketing communications from the Sponsor. Participants are not required to opt-in to receive marketing communications from Sponsor to enter the Sweepstakes, and opting in will not improve your odds of winning.

**SWEEPSTAKES PRIZE DRAWING & WINNER NOTIFICATION:** Odds of winning will depend on the number of Sweepstakes Entries received during the Sweepstakes Period. Winners will be selected and notified on August 7, 2026. Winners will be randomly selected under the discretion of the Administrator. Winners will be contacted via email.

The potential Winners ("Potential Winners") will be required to acknowledge receipt of Winner notification within three (3) days of the date Administrator emails the applicable Potential Winner. The grand prize Potential Winner will need to execute and return an affidavit of eligibility, a taxable income form, a liability release, and where lawful, a publicity release, all within three (3) days of date of issuance of such notification email. If such documents or information are

not returned within the specified time period, the Prize notification is returned as undeliverable, the Sponsor or its agent is unable to contact a Potential Winner, a Potential Winner declines the Prize for any reason prior to award, or a Potential Winner is not in compliance with these Official Rules, the Prize will be forfeited and, at the Sponsor's discretion, an alternate Winner may be selected. The Sponsor reserves the right not to award any Prize in the event the Sponsor is unable to identify and confirm a Winner after attempting to contact an alternate Potential Winner. Sponsor is not responsible for any cancellations, delays, diversions, or substitutions, or any act or omission whatsoever with respect to any Prize.

**SWEESTAKES GRAND PRIZE (1):** There is one (1) grand prize ("Grand Prize") available to be awarded. The Potential Winner of the Grand Prize will be the first person chosen during the drawing on August 7, 2026. Grand Prize trip is scheduled to take place on September 18-20, 2026, and the Grand Prize Winner cannot change the trip dates. Grand Prize Winner ("Grand Prize Winner") will receive a trip to Miami, Florida, USA, which includes (a) round-trip coach air transportation, to be arranged by Sponsor or Administrator, for Grand Prize Winner and one (1) guest ("Guest") (from a major airport near Grand Prize Winner's home) to Miami International Airport. Grand Prize Winner and Guest are responsible for traveling to and from a major commercial airport near Grand Prize Winner's residence. (Approximate Retail Value ("ARV") \$1,500; exact value will depend on Grand Prize Winner's location); (b) double-occupancy, standard hotel accommodations (one (1) room) for two (2) nights at the 1 Hotel South Beach (ARV \$1,867.32); (c) VIP dinner experience for Grand Prize Winner and Guest to occur on September 19, 2026 (ARV \$500); (d) one (1) \$500 Publix Super Market eGift Card; and (e) two of the following gift sets, and Winner can choose to share with Guest: an insulated bag (ARV \$34.36), that includes one (1) cutting board (ARV \$47.10), one (1) dinner mug (ARV \$13.56), one cheese hugger (ARV \$7.99), assorted cheeses (ARV \$50), one (1) loafie (ARV \$16.76), one (1) tea towel (ARV \$10.36), one (1) hat (ARV \$29.99), one (1) ice cream dish (ARV \$3.96), one (1) high-end robe (ARV \$181.32), and one (1) signed cookbook from Mika Leon (ARV \$50) (each gift set is worth ARV \$445.40, for a total ARV of \$890.80 for both gift sets). Grand Prize Winner and Guest must be able to travel September 18-20, 2026. If the potential Grand Prize Winner and Guest are unable to complete travel on dates specified, the Grand Prize will be forfeited, and Sponsor will have no further obligation to such potential Grand Prize Winner. Travel arrangements must be made through Administrator, on a carrier of Administrator's choice. **The Approximate Retail Value ("ARV") of the Grand Prize is \$5,258.12.**

**SWEEPSTAKES 1<sup>ST</sup> PRIZES (25):** There are twenty-five (25) 1<sup>st</sup> prizes ("1<sup>st</sup> Prizes"). The potential 1<sup>st</sup> Prize winners will be the next twenty-five Sweepstakes Entries randomly drawn on August 7, 2026 after the Grand Prize Winner is drawn. Each 1<sup>st</sup> Prize Winner will receive one (1) \$100 Publix Super Market eGift Card. **The Total ARV of All 1<sup>st</sup> Prizes is \$2,500**

**The ARV for the Grand Prize and 1<sup>st</sup> Prizes (collectively “Prizes”) is \$7,758.12. A Participant is only eligible to win one prize.**

**PRIZE CONDITIONS:** The 1<sup>st</sup> Prizes will be emailed to the email address provided at time of registration. 1<sup>st</sup> Prizes may take 4-6 weeks to arrive after the Sweepstakes ends. Sponsor or Administrator will coordinate delivery of the Grand Prize to the Grand Prize Winner directly.

The Grand Prize Winner and all 1<sup>st</sup> Prize Winners are referred to as “Winner(s).” The Grand Prize and all 1<sup>st</sup> Prizes are referred to as the “Prize(s).” Each Winner is responsible for all applicable federal, state, local sales and income taxes for the Prize won and any costs, expense(s), or fees whatsoever in connection with the Prizes not specifically provided herein. In the event that, for reasons beyond their control and not related to the Winner, the Sponsor or any independent third-party company is unable to award any Prize as described in these Official Rules (including if the designated Prize should become unavailable for any reason), the Sponsor will substitute the Prize with another prize of similar nature and equal or greater value at its sole discretion. All Sweepstakes Entries and the Potential Winners are subject to verification by the Sponsor and the Administrator, whose decisions are final and binding.

Prizes will be awarded provided that a sufficient number of Sweepstakes Entries are received, and the Prizes are claimed in accordance with the dates and times specified above. **NO FURTHER OBLIGATION:** Upon awarding the Prizes, Sponsor shall have no further obligation to Winners.

**TRAVEL CONDITIONS FOR GRAND PRIZE:** Grand Prize Winner and Guest must be able to travel September 18-20, 2026. In the event that the Grand Prize Winner lives within a 150-mile radius of Miami, FL, a fuel allowance will be provided of up to a maximum of \$250 and parking to a maximum of \$200 in lieu of airfare. If the Grand Prize Winner elects to partake in any or all portions of his/her Grand Prize with no Guest, only the applicable portion of the Grand Prize will be awarded to Grand Prize Winner, and any remainder of the Grand Prize will be forfeited and shall not be subject to further or alternative compensation. All elements of the Grand Prize must be redeemed at the same time, and no changes will be permitted after confirmation. Air or ground transportation and hotel accommodation (collectively “Travel”) arrangements must be made through Administrator, on a carrier of Administrator’s choice. Guest must be eighteen (18) years of age or older as of the date of departure, or Winner must be parent or guardian of Guest. Guest might be required to sign, or to have a parent or guardian sign on Guest’s behalf, a release of liability and, if permitted by law, a publicity release. Specific travel dates and arrangements are subject to air travel, holiday, blackout dates, and other Grand Prize and travel restrictions. Reservations are subject to availability. Travel dates are subject to Sponsor or a third party’s approval. The maximum value of the Grand Prize set forth above

represents the Sponsor's good faith determination of the maximum ARV. The actual fair market value, as ultimately determined by the Sponsor, cannot be challenged, or appealed. The Grand Prize Winner will receive from the Administrator an IRS Form 1099 (or similar) in the amount of the Grand Prize, and the Grand Prize Winner is solely responsible for filing this completed form with the Internal Revenue Service.
